Entered the premises of Krishnendu Chatterjee Vill Amchator  
P.S. Santalaloh Dist- Purulia, having Consumer No. 242074995 Meter No. B2369569  
and inspected his premises. During the inspection theft of electricity was detected i.e. by passing the energy meter i.e. U/S135(1) was detected. The details of passing the arrangement was damage installation of the incoming wire and top 2 (two) piece of wire by which electricity directly flow to his house without energy registration in WBSSEDCL energy meter.

From the above by-passing system he/she uses the following electrical equipments.

- 1) Electric Fan - 3 Nos
- 2) Color TV - 01 No
- 3) LED - 5 Nos

Out of which I seized the following.

P.V.C Service Connection Cable (Tempered) along with by-passing arrangement - 2 ft along with energy meter and meter No. B2369569  
Seizure list was prepared at the site and accused person refuse to sign. The inspection team left the premises at 12:53 PM on 25/07/19. The accused person has committed an offence U/S135(1) of the electricity act.-2003 subsequently electricity (Amendment) act.- 2007.
