During the inspection theft of electricity was detected i.e. by passing the energy meter i.e. U/S135(I) was detected. The details of passing the arrangement was damage installation of the incoming wire and top 2 (two) piece of wire by which electricity directly flow to his house without energy registration in WBSEDCL energy meter.

From the above by-passing system he/she uses the following electrical equipments.

PVC Service Connection Cable (Tempered) along with by-passing arrangement 2.6 ft. along with energy meter viele meter No. B2 369569 Seizure list was prepared at the site and accused person refuse to sign/signed. The inspection team left the premises at 12:53PM on 25/07/19. The accused person has committed an offence U/S135(I) of the electricity act-2003 subsequently electricity (Amendment) act- 2007.
