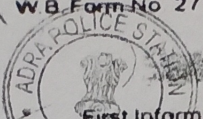

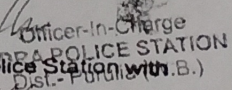

Sir,

In producing here with one arrested accused namely Mukesh Prasad (40 Yrs) S/O Arjun Prasad of Lower Beniasol, PS-Adra, Dist- Purulia along with following seized articles viz-

- 1) 12 bottles (in sealed condition) DIL KHUSH country spirit, 300-ml each bottle, Rs-22 of each bottle.
- 2) Ten pieces of plastic glasses.

I ASI Parimal Tewary of Adra PS do here by lodged a complaint against accused namely Mukesh Prasad (40 Yrs) S/O Arjun Prasad of Lower Beniasol, PS-Adra, Dist- Purulia to the effect that on 08/08/19 at about 18:45 hrs in course of my evening mobile duty I received a telephonic information from a reliable source that one Mukesh Prasad was stocked of country spirit illegally and selling the same to hike price for his personal gain then I informed O/C Adra PS and as per his direction I along with force. At about 18:55 hrs. reached at Lower Beniasol village and hold raid in the dwelling house of Mukesh Prasad found that said Mukesh Prasad selling liquor at his house and seeing the Police party some person fled away and said Mukesh Prasad to concealed himself but I able to apprehend him and also detained him. I asked him to produced valid License or valid papers of selling country spirit but he failed to produce any valid license or documents for possessing /selling the same, So I seized the above mentioned articles after preparing proper seizure list duly sign by accused person and available witnesses and arrested the above mentioned accused person informing the ground of arrest.

Hence I there for pray that a specific case may kindly be started against arrested accused Mukesh Prasad (40 Yrs) S/O Arjun Prasad of Lower Beniasol, PS-Adra, Dist- Purulia and arrange for its investigation.
