I do hereby lodge a complaint empowered by enabling the Electricity act 2003 subsequently Electricity (Amendment) Act-2007 to the effect that Sri Niranjan Tiwary S/O- Lt- Nandkishor Tiwary of Village- Kalikend, P.O- Adra, P.S- Purulia, Dist-PURULIA has committed theft of Electricity U/S-135 of the Electricity (Amendment) Act-2007.

On dated 22/08/2019 at about 12:20PM, Sri KHAGENDRA DAS, Station Manager Adra CCC Customer Care Centre, WBSEDCL along with,

Entered the premises of Niranjan Tiwary, S.O- Lt Nandkishor Tiwary of Village- Kalikend, P.O- Adra, P.S- Purulia Adra Dist-Purulia. and inspected his premises.

During inspection theft of Electricity was found, i.e. he/she was using Electricity dishonestly

by illegal drawing bypassing from incoming service cable before energy meter.

Supply i.e. U/S 135 was detected.

From the above system he/she was using the following Electrical equipments i.e.

- 1) Fan = 4 No's = 240 watt , ③ Fridge - 1 No's = 200 watt ⑤ CFL = 36
- 2) TV = 4 No's = 40 watt ④ Incandescent bulb = 2x60 = 120 watt

Out of which we seized the following:

Tapping arrangement with meter Box (Meter No - L4230363) and 2 ft Service Cable (Black roof/put).

The seizure list is prepared at the site and the accused person signed in the seizer list

The inspection team left the above premises at about 12:30pm on dated 22/08/2019. The accused person has committed an offence U/S-135(i)(B) of the Electricity (Amendment) Act-2007.
