





The above name complainant begs to state as follows:


- Charan Gorai and the marriage was solemnized on 28th Baisakh 15 years according to Hindu rites and customs as prevalent in their community and also by observing the formalities like putting on vermilion, exchange of garlands, Home etc and the said marriage is still subsisting.
- That at the time of marriage father of the complainant as per demand of the accused persons has paid as cash of Rs. 95,000/-, Golden and Silver ornament and one Motor Cycle along with other valuable articles in-spite of that the accused persons were not happy with those articles.
- That after marriage the complainant had been to her matrimonial house and started to resided therein with her Page 2 of 7



their marriage was consummated. In their wedlock two daughters were born. For about one year about their marriage the husband of the complainant and others inmates of the family behaved the complainant well.

- 4) That meanwhile the complainant conceived and gives birth a female child namely Sonamoni Gorai in due course after birth of the female child the husband of the complainant and his inmates were not happy, thereafter another daughter namely Jhuma Gorai was born.
- That after birth of the second daughter the above noted of Pakis immels became very much annoyed upon the resulting complainant as the complainant failed to give birth any male child.
- 6) That the above noted accused persons without any issue put pressure upon the complainant in various ways though the complainant tried her level best to satisfy all of them with her best efforts.
- 7) That the husband is a habitual drunker and he along with the above noted accused persons started all sorts of inhuman,






physical as well as mental torture upon the complainant, they even did not provided proper food and clothing even to the said two minor babies. However, all such torture the complainant somehow managed to stay at her matrimonial house.


- 8) That when such state of thing was going on the above noted accused persons asked the complainant to bring a cash of Rs. 60,000/- from her father as further dowry on the ground that she gave birth a female child. The father of the complainant being a poor man failed to pay the said money but the father of the complainant somehow paid Rs. 10,000/- and Rs. 5,000/- in two occasions, but they stated by her father that unless another Rs. 45,000/- be paid to them within 15 days they will not allowed the complainant to stay in their house.
- Out the complainant from their house after good assault and the complainant along with her two minor daughters compelled to come back at her paternal house.

Thereafter, when the above noted accused persons did not taken any information of the complainant and her minor



daughters nor even make any arrangement to bring them back in their house then the parents of the complainant to keep the complainant with proper manner and prestige when they assaulted the parents of the complainant and drive them out form their house.

- 10) That the complainant sent a pleader notice through her Advocate to her husband requesting him to take her back and her minor two daughter in his house for resuming conjugal life, but the husband of the complainant and his inmates did not bring her back in his house.
- members after receiving the said notice became very much annoyed and they also with some unknown persons all on a sudden on 21/07/2019 came to the paternal house of the complainant at village- Serengdih, P.O. Serengdih, P.S. Bagmundi, Dist- Purulia when the complainant think that they came to bring the complainant back to their house, but it was not their intention but they started to quarrel with the complainant and her parents.



- That in course of such quarrel the husband of the complainant with the instigation of other named above assaulted the complainant with fest and blows.
- Office-in-charge of local P.S. as well as the Superintendent of Police Purulia but no legal action yet been taken under the law. Hence, the complainant is compelled to file this complainant before the Ld. Court

In the circumstances it is therefore, prayed that your honour may be pleased to send the petition of complaint to the Officer-in-Charge, Bagmundi P.S. treating the same as FIR under section 156(3) for investigation.
