And also seized in his possession 1) Approx 15 Ltr Country Spirit kept in 03 Plastic container, 2) 05 (Five) Pcs Plastic Glasses, 3) One sample bottle (wchich collected from 03 seized plastic container 5) Cash Rs. 55/- (Fifty Five only) as sale proceed which were seized under proper seizure list duly signed by the witness U/S- 67 B.E. Act. A sample ID liquor taken out as sample and all seized articles were labeled properly in presences of witness and accused person. Hence I arrested the above noted person at 19:45 hrs. During arrest the ground of arrest was duly notified, issued arrest memo U/S- 50 Cr.P.C and handed over a copy of the same to the arrested person.
