In producing herewith the accused person namely Shibaram Gope (34 Yrs), S/O-Shambhu Gope of Vill-Mankidih, PS-Tiruldih, Dist-Saraikela Kharsana (JKD) along with seized articles 1) Approx 15 Ltr Country Spirit kept in 03 Plastic container, 2) 05 (Five) Pcs Plastic Glasses, 3) One sample bottle (wchich collected from 03 seized plastic container 5) Cash Rs. 55/- (Fifty Five only) as sale proceed, which were seized under proper seizure list duly signed by the witness.

I beg to submit that today on 27.08.19 during the special raid duty as per source information I along with 1. C/564 Prasad Majhi, 2. JC/549 Arun Kumar Duley, 3. JC/1072 Gopi Ballab Guin all are of Baghmundi P.S reached at Gatsakra Village at 19.05 hrs and found that the above noted person is selling I.D liqure at his old house situated at Gorait Sakra village under Baghmundi P.S, Dist Purulia. On demand he failed to produce any valid document from competent authority in respect of stocking & selling of liquor. As such he was arrested U/S- 67 B.E. Act. And also seized in his possession 1) Approx 15 Ltr Country Spirit kept in 03 Plastic container, 2) 05 (Five) Pcs Plastic Glasses, 3) One sample bottle (wchich collected from 03 seized plastic container 5) Cash Rs. 55/- (Fifty Five only) as sale proceed which were seized under proper seizure list duly signed by the witness U/S- 67 B.E. Act. A sample ID liquor taken out as sample and all seized articles were labeled properly in presences of witness and accused person. Hence I arrested the above noted person at 19:45 hrs. During arrest the ground of arrest was duly notified, issued arrest memo U/S- 50 Cr.P.C and handed over a copy of the same to the arrested person.

The above noted arrested accused person namely Shibaram Gope (34 Yrs), S/O-Shambhu Gope of Vill-Mankidih, PS-Tiruldih, Dist-Saraikela Kharsana (JKD) committed an offence U/S- 46 A(c) B.E. Act. 1909 for unauthorized possession and selling of Id Liquor from his sole possession

Under the fact and circumstances I therefore pray before you a specific Case may kindly be started against the said accused person under proper section of law and obliged.
