I ASI Animesh Pati of Balarampur PS beg to state that today on 15.08.19 at 09:15 hrs. While I was engaged in Naka checking duty at Dantia under Balarampur P.S, we stopped and checked one Toyota Innova Car in which two persons were boarded & I asked to produce valid paper in respect of above noted Toyota Innova Car bearing Reg. No.-OD02AR/4596 but they failed to produce any valid papers in respect of above noted car after that I interrogated them regarding the possession and ownership of the car but they could not provide any satisfactory reply. On further interrogation they confessed that they have stolen that car and going to sell this to one Md. Noor Alam (35 yrs) S/O- Md. Ayub Alam of Asansol Rail Park, Dumuria Mohlla, PS-Asansol North, Dist-Paschim Bardhaman at Asansol area. Further they also revealed that they along with Md. Noor Alam S/O- Md. Ayub Alam of Asansol Rail Park, Dumuria Mohlla, PS-Asansol North, Dist-Paschim Bardhaman and some others are habitually dealing in stolen property since last few years.

Accordingly I seized the Toyota Innova Car Bearing Reg. No.-OD02AR/4596 Engine No.-2GD A147144 chassis No- MBJJB8EMX01529760-1117 after preparing proper seizure list duly signed by accused persons and accompany Police persons because the local people refused to sign in seizure list.
