Respected Sir,

In producing here with one arrested accused person namely Haradhan Gorain @ Baliraj (40 yrs) S/O- Bhisma Gorai of Vill.+P.O.- Rangadih, P.S.- Balarampur, Dist. Purulia along with seized 15 (fifteen) sealed country sprit bottles (DIL SE) Each Bottle 600 ML (details of seized articles are mentioned in attached seizure list), I beg to submit that today at about 18:15 hrs. I received a credible source information that one Haradhan Gorain @ Baliraj S/O- Bhisma Gorai of Vill.+P.O.- Rangadih, P.S.- Balarampur, Dist. Purulia is selling country sprit without any valid license from his own Food shop at Rangadih village under Balarampur P.S., Dist.-Purulia. Accordingly, I inform to O/C Balarampur P.S. regarding this matter and as per order of O/C Balarampur P.S. I along with force left for Rangadih village to work out the source information. Thereafter we reached at Rangadih village at about 18:45 hrs as per source information and held raid in the Food shop of Haradhan Gorain @ Baliraj.

During search with the help of accompany with force, we found that the said person is selling country sprit bottles (DIL SE) in his Food shop. On demand, he failed to produce any valid documents or valid License in respect of selling and keeping of said country sprit. Accordingly, I seized all the sealed country sprit bottles (details in seizure list) after preparing proper seizure list duly signed by the witnesses and labelled one bottle as a sample. Total 15 (fifteen) sealed country sprit bottles (DIL SE) Each Bottle 600 ML and arrested him after preparing proper arrest memo as he committed offence U/S 46A(C) B.E. Act 1909 after maintaining all the formalities as per NHRC guide line.

Under the above circumstances and fact, I therefore pray that a cog case may kindly be started U/S 46A(C)B.E. Act against the arrested accused person namely Haradhan Gorain @ Baliraj (40 yrs) S/O- Bhisma Gorai of Vill.+P.O.- Rangadih, P.S.- Balarampur, Dist. Purulia to start a cog case U/S 46A(C)B.E. Act and arrange for its investigation.
