In producing herewith two accused persons namely 1)Uday Kumar (33 yrs) S/O- Ketab Kumar, of Vill-Hutu, PO-Muru, PS-Nimdih, Dist.-Saraikela Kharswan A/P address Vill-Rapkata, PS-Balarampur, Dist-Purulia 2) Himangsu Mahato (33 yrs) S/O- Rampada Mahato of Vill-Ruchap, PS-Balarampur, Dist-Purulia along with following seized articles i) 345 pieces FICNs having denomination of Rs.-2000/- (2000x345= Rs.-6,90000/-) and 15 pieces FICNs having denomination Rs.-500 (500x15= Rs-7500/-) Amounting Rs.-6,97,500/- (Six lakh ninety seven thousand five hundred) fake currency of serial numbers a) 9CS651126 [68 notes (same serial number) x Rs-2000/-] b) 7DF120584 [46 notes (same serial number) x Rs-2000/-] c) 4GE294509 [45 notes (same serial number) x Rs-2000/-] d) 6GR529409 [45 notes (same serial number) x Rs-2000/-] e) 5CH272274 [43 notes (same serial number) x Rs-2000/-] f) 1DE953602 [27 notes (same serial number) x Rs-2000/-] g) Without having any serial number (71 notes of Rs 2000/-) h) 4QH528476 [15 notes (same serial number) x RS-500/-] ii) One Maruti Suzuki Car, Model No- Alto 800 bearing Reg. I ASI Somenath Mahanti of Balarampur PS beg to state that today on 29.08.19 at 08:15 hrs. While I along with JC/631 Dhritiman Sannigrahi & AB SI Vitsulie Rio along with fifteenth personnel of 14th NAP IR Bn. 'A' Coy Of Patharbandh Camp under Balarampur PS were engaged in Naka checking duty at Suraidih More under Balarampur P.S, vide duty command certificate Regt. No-140045 dated-29.08.19, we stopped one Maruti Suzuki Car, Model No-Alto 800 bearing registration no- JH05BX/2470 at Suraidih More under Balarampur P.S in which two persons were boarded. During checking the vehicle I, found four bundles of Rs-2000/- among which the bundles contained 113 pieces of Rs-2000/-, 88 pieces of Rs-2000/-, 73 pieces of Rs-2000/-, 71 pieces of Rs-2000/-, respectively & one bundle containing 15 pieces of Rs.-500/- notes amounting to Rs-6,97,500/- from the front side pocket of wearing pant of detained person Uday Kumar. Since it is a huge amount, I interrogated them regarding possession of such huge money with them and also asked to produce valid paper in respect of above noted Maruti Suzuki Car, Model- Alto 800 bearing Reg. No-JH05BX/2470 but neither they could reply any satisfactory with regard to the possession of such huge money nor could produce any valid papers in respect of above noted car. On further interrogation they confessed that the notes are fake and they came here at Balarampur to sell the same. Accordingly, on verification of those recovered note it is found that the notes were forged in respect of quality & several notes were found containing same serial numbers and few found having without any serial number affixing white blank paper on the back side of the note. On interrogation they disclosed their identity as noted above & also stated that they used to collect FICN from Jharkhand area and sell the FICN with the help of some local traders.

Accordingly I seized the recovered FICN, one Maruti Suzuki Car, Model-Alto 800, Four old Coins & three mobile phones under proper seizure list, duly signed by the Police witnesses as well as the accused persons. After seizure, FICN and other seized articles were sealed and labelled properly on the spot, duly signed by the apprehended persons as well as the Police witnesses also. Then I arrested the accused persons maintaining all guide lines regarding arrest and informed them the ground of arrest.

Therefore I pray that a specific case may kindly be registered against the following accused

person under proper section of law.
