Respected Sir,

In producing here with one arrested accused person namely Kalebar Mahato (32 yrs) S/O- Chapal Mahato of Vill.- Dubrajpur, P.O- Raigara, P.S.- Barabazar, Dist. Purulia, A/P- Usha Hotel Namsole, P.S.- Balarampur, Dist.-Purulia along with seized 14 (fourteen) sealed country sprit bottles (DIL KUSH) Each Bottle 600 ML (details of seized articles are mentioned in attached seizure list), I beg to submit that today at about 18:45 hrs. I received a credible source information that one Kalebar Mahato S/O- Chapal Mahato of Vill.- Dubrajpur, P.O- Raigara, P.S.- Barabazar, Dist. Purulia, A/P- Usha Hotel Namsole, P.S.- Balarampur, Dist.-Purulia is selling country sprit without any valid license from his own Usha Hotel Namsole under Balarampur P.S., Dist.-Purulia. Accordingly, I inform to O/C Balarampur P.S. regarding this matter and as per order of O/C Balarampur P.S. I along with force left for Usha Hotel Namsole to work out the source information. Thereafter we reached at Usha Hotel Namsole at about 19:15 hrs as per source information and held raid in the Usha Hotel of Kalebar Mahato.

During search with the help of accompany force, we found that the said person is selling country sprit bottles (DIL KUSH) in his Usha Hotel. On demand, he failed to produce any valid documents or valid License in respect of selling and keeping of said country sprit. Accordingly, I seized all the sealed country sprit bottles (details in seizure list) after preparing proper seizure list duly signed by the witnesses and labelled sample bottles. Total 14 (fourteen) sealed country sprit bottles (DIL KUSH) Each Bottle 600 ML and arrested him after preparing proper arrest memo as he committed offence U/S 46A(C) B.E. Act 1909.

Under the above circumstances and fact, I therefore pray that a cog case may kindly be started U/S 46A(C)B.E. Act against the arrested accused person namely Kalebar Mahato S/O- Chapal Mahato of Vill.- Dubrajpur, P.O- Raigara, P.S.- Barabazar, Dist. Purulia, A/P- Usha Hotel Namsole, P.S.- Balarampur, Dist.-Purulia and arrange for its investigation.
