Sir,

I do hereby lodge complaint, empowered by enabling "The Electricity Act, 2003" subsequently electricity act-2007 to the effect that Priyachand Majhi S/O Budha Majhi of Vill- Satsayerdih, P.S- Barabazar, Dist- Purulia, his family was enjoying electricity illegally by hooking from nearest LT OH line with the help of single core flexible wire and he has committed theft of electricity U/S 135(1)/a of the electricity (Amendment act-2007).

On 16.08.2019, I Sri ANSHUMAN MITRA, A.E. & S.M., BARABAZAR CCC, WBSEDCL along with

- (1) SAHEB SUTRADHAR, S.A.E(E), BARABAZAR CCC, WBSEDCL
- (2) MD QASIM ANSARI, O.E., BARABAZAR CCC, WBSEDCL

At About 05:46 P.M., entered into the premises of Priyachand Majhi S/O Budha Majhi of Vill- Satsayerdih, P.S- Barabazar, Dist- Purulia and inspected his premises at Vill.- Satsayerdih, P.S Barabazar, DIST- Purulia.

During inspection, it was found that Priyachand Majhi S/O Budha Majhi of Vill- Satsayerdih, P.S- Barabazar, Dist.- Purulia, his family was enjoying electricity illegally hooking from nearest LT OH line with the help of single core flexible wire in his premises at Satsayerdih having connected load 0.071 KVA.

From the above arrangement he was using the following arrangements:

01. 01 no electric Bulb (60 watts)
02. 02 nos of single core flexible wire (13 Mtrs. App.) along with hooking device

Out of which I seized the following articles:

01. 02 nos of single core flexible wire (13 Mtrs. App.) along with hooking device

Seizure list was prepared at site. After process of inspection and seizure list we left the premises at about 06:07 p.m.

The said person has committed an offence U/S 135(1)/a of electricity act 2003 subsequently electricity (Amendment) act-2007.

You are requested to take cognizance of this complaint and treat it as F.I.R and action may be taken as per rule. The FIR could not be lodged on 16.08.2019 due to continuation of raid programme till 9:30 P.M at other villages under the jurisdiction of Barabazar CCC.
