Sub: Complaint against Sumitan Mandi (35 Yrs), S/O- Lt. Bulai Mandi of Vill- Paisagora PS- Boro, Dist - Purulia to start a case U/S- 46A(C) B.E. Act 1909.

Respected Sir.

In producing herewith one arrested accd. person Sumitan Mandi (35 Yrs), S/O- Lt. Bulai Mandi of Vill- Paisagora PS- Boro, Dist - Purulia with seizure of approx 20 liters illicit spirit, containing in 02 (two) white jerkin which carrying by him from the possession of above noted accused which was seized under proper seizure list.

I beg to submit that today (27.08.19) during night mobile duty in between 02.45 hrs to 03.30 hrs on acting a secret source information I apprehended the above noted person at Dharampur village road near Hari Mandir who was moving towards Paisagora village. After thoroughly searching I found that he was carrying approx 20 liters illicit spirit, containing in 02 (two) white jerkin which carrying by him. On interrogation he disclosed his name and address as noted above. On demand he failed to produced any valid documents in r/o carrying of illicit spirit which is kept 02 (two) white jerkin containing approx 20 ltrs. Accordingly I seized the same under proper seizure list in presence of witnesses, u/s 67 A (C) B.E. Act which is enclosed herewith. As such he was arrested at 03.15 hrs u/s 67 B.E. Act and during arrest the ground of arrest were duly notified issuing arrest memo u/s 50 Cr. P.C. and handed over a copy of the same to arrestee. Out of seized illicit liquor 01 lts taken out in a separate container as sample with sealed & labeled.

The above noted arrested accd Sumitan Mandi (35 Yrs), S/O- Lt. Bulai Mandi of Vill- Paisagora PS- Boro, Dist - Purulia violate section 18(i) B.E. Act. for possession of intoxicating not obtained from a licensed vendor and in contravention and he Committed offence u/s 46 A (C) B.E. Act. 1909.

It may note here that during raid (1) C/181 Rabban Sekh, (2) C/1361 Munsi Kamal Hassan accompanied me.

Under the fact and circumstanced I therefore pray a case u/s 46 A (C) B.E. Act. 1909 may kindly be started against Sumitan Mandi (35 Yrs), S/O- Lt. Bulai Mandi of Vill- Paisagora PS-Boro, Dist - Purulia.
