In producing herewith 02(Two) arrested accd. persons namely i) Narattam Mahato, S/O- Lt. Jadav Mahato of Vill- Jargo, PS- Jhalda, Dist- Purulia and ii) Avijit Baisnab S/O- Mathur Baisnab of Jhalda Anandabazar, Ward No. 11, PS- Jhalda, Dist- Purulia and lodged this complaint to the effect that today i.e. on 31/07/19 I SI Anjan Kr. Biswas along with force C/571 Md. Hasib Khan, C/1376 Tapan Das, NVF/857 Rajkumr Gorain and NVF/778 Samir Kr. Mahato were engaged in evening mobile duty at Jhalda /PS area vide Jhalda PS C.C. No-1925/19 dated-31/07/19. While performing mobile duty at 19:15 hrs. at Birsa more under Jhalda PS I received a source information that an illegal gambling was going on in an open field at Ichag Kochakuli. I informed this to I/C Jhalda PS and as per his direction myself along with my accompanying force and some local C.V.Fs went to Ichag Kochakuli, reached there at 19:45 hrs. and held raid against the accd. persons who were playing gambling. Seeing the Police party the accd. persons fled away from the spot. When we were returning back gamblers and about 40/50 mob attacked us with lathi, iron rod and bricks by পুলিশ গুলোকে আজ মেরে শেষ করে দেব ।"They assaulted us by fist and blow, lathi, iron rod while we were discharging our lawful duties. As a result I SI. Anjan Kr. Biswas C/ 1376 Tapan Das, NVF/857 Rajkumr Gorain and NVF/778 Samir Kr. Mahato and C.V.Fs received grievous injuries. They also took away Mobile phone and cash Rs-3500/- from the possession of C/ 1376 Tapan Das. So, I asked I/C Jhalda PS for reinforcement. After few minutes SI. Bsubed Acharya, SI. Gagan Baisnab, and ASI. H.R. Mandal along with force reached there. After seeing large member of Police, gamblers and the mob started to fled away but somehow we managed to apprehend 02 (two) accd. persons. On interrogation they disclosed their identity as noted above and confessed their guilt and stated that they along with i) Bundka Mahato of Ichag Kochakuli, ii) Barua Mahato of do, iii) Chattu Rajak of do, iv) Ghuhiram Rajak of do, v) Lalu Mahato of Jargo, vi) Muruli Mahato of Jamlohar, PS- Jhalda, vii) Fucha Kumar of Matkuma, PS- Kotshila, viii) Shailen of do were involved in gambling and present at the time of incident and 40/50 others were also present at the time. I arrested above noted 02 (two) accd. persons maintaining all formalities of arrest. Then we are treated at Jhalda B.P.H.C. and C/1376 Tapan Das has been referred from Jhalda B.P.H.C. for as he is in critical condition.

Therefore, I pray before you to start a specific case under proper section of law against above noted 02 (two) arrested accd. persons and i) Bundka Mahato of Ichag Kochakuli, ii) Barua Mahato of do, iii) Chattu Rajak of do, iv) Ghuhiram Rajak of do, v) Lalu Mahato of Jargo, vi) Muruli Mahato of Jamlohar, PS- Jhalda, vii) Fucha Kumar of Matkuma, PS- Kotshila, viii) Shailen of do and 40/50 others.
