In producing here with arrested accused persons namely (1) Sk. Ashikul (26 yrs) S/O- Sk. Ejahar of Sir, Vill-Hussaindih, PS- Jhalda, Dist-Purulia. (2) Raban Gorai (25 yrs) S/O-Lt. Chandi Gorai of Jhalda Ojhapara, Ward No-III, PS-Jhalda, Dist-Purulia. (3) Sk. Sarunur Khan (24 yrs) S/O-Samir Khan of Vill-Hussaindih, PS-Jhalda, Dist-Purulia and (4) Sk. Ramjan (25 yrs) S/O-Imamuddin of Vill-Hussaindih, PS- Jhalda, Dist-Purulia and brought under seizure (1) One iron made improvised country made one Shooter fire arms and 01 round 8 mm ammunition (engraved at the back K.F 8 MM) fitted with butt; body; barrel; firing pin; overall length 20 cm including barrel length 7 cm, , (2) one iron made BHOJALI, total length 30 cm including 8 cm wooden butt (3) one iron made sharp ending punching (fighter), (4) one iron made SABAL length about 3.5 feet, (5) Sketch map of Dacoity and (6) One Lylon rope about 30 ft. I beg to lodge this complaint to the effect that today (28/08/19) at 23:15 hrs. received a credible source information that a gang (approx 15/16) of dacoits are being assembled at the back side busy area of Jhalda B.P.H.C. and are preparing themselves to commit dacoity at nearby houses of hospital and vehicles on Jhalda Gola road. I informed this matter to I/C Jhalda PS and noted the fact in GD vide Jhalda PS GDE No- 1063 dated-27/08/19. As per order I SI. Basudeb Acharya along with SI. Nimai Ch. Nemo, ASI. Bikash Patra, C/1179 Pabitra Mandal and C/ 132 Hydar Ali left for Jhalda B.P.H.C. to work out the information with Govt. vehicle WB 56C/ 8741 vide Jhalda PS GDE No- 1064 dated-27/08/19 and C.C. No-2202/19 dated-27/08/19. I also informed night duty officer ASI. Habibul Rahaman Mandal with his accompanying force C/497 Ambuj Mandal, C/571 Md. Hasib Khan, NVF/778 Samir Mahato and NVF/039 Lalit Kishor Mahato Vide C.C. No- 2200/19 dated- 27.08.19 to reach near Jhalda B.P.H.C.

Then, I along with accompanied officers and force reached about 200 miters from Jhalda BPHC on Jhalda Gola road at about 23:45 hrs and meet with night duty officer ASI. Habibul Rahaman Mandal and kept out vehicle by the side of road in a dark. Then I briefed all officers and force properly and we started to proceed towards back side of Jhalda BPHC on foot and when we reached near back side of Jhalda BPHC found 15/16 persons sitting in that busy area and whispering each others. Their voice was clearly audible to us due to night & the place was silent zone. They were planning to commit dacoity at nearby houses of hospital and vehicles on Jhalda Gola road. After confirmation, we cordoned the area secretly and loudly disclose our identity with a direction to surrender before us. But, all of them tried to run away seeing the police party. However, we managed to apprehend 04 (four) out of them after a hot chase. Accordingly, I interrogated them thoroughly where they disclosed their identity as-

(1) Sk. Ashikul (26 yrs) S/O- Sk. Ejahar of Vill-Hussaindih, PS- Jhalda, Dist-Purulia.

(2) Raban Gorai (25 yrs) S/O-Lt. Chandi Gorai of Jhalda Ojhapara, Ward No-03, PS-Jhalda, Dist-Purulia.

(3) Sk. Sarunur Khan (24 yrs) S/O-Samir Khan of Vill-Hussaindih, PS- Jhalda, Dist-Purulia and

(4) Sk. Ramjan (25 yrs) S/O-Imamuddin of Vill-Hussaindih, PS- Jhalda, Dist-Purulia

During chase we could identify following accused persons through our search light but they could not be apprehended-

(i) Tinku Das @ Chingri of Jhalda Anandabazar Hat tola, PS-Jhalda, Dist-Purulia.

(ii) Sk. Abbas of vill-Kantadih, PS-Jhalda, Dist-Purulia.

(iii) Sk. Imroj @ moja of vill-Kantadih, PS-Jhalda, Dist-Purulia.

(iv) Sanjay Karmakar of Jhalda School more, Mosina, PS-Jhalda, Dist-Purulia.

(v) Dulal Bauri @ Methra of vill-Pat Jhalda, PS-Jhalda, Dist-Purulia.

(vi) Abdul Malik @ Hati of Vill-Hussaindih, PS- Jhalda, Dist-Purulia

On interrogation of the about noted apprehended persons confessed that they along with above noted accused persons and 05/06 others under the leadership of Sk. Ashikul being armed with deadly weapons were assembled and preparing themselves for committing dacoity at nearby houses of hospital and vehicles on Jhalda Gola road. Accordingly, I arrest them maintaining all formalities of arrest, issue memo arrest and informed them the ground of arrest. On search, we recovered and seized the following weapons after preparing proper seizure list & labels duly signed by the witnesses –

(i) One iron made improvised country made one Shooter fire arms and 01 round 8 mm ammunition (engraved at the back K.F 8 MM) fitted with butt; body; barrel; firing pin; overall length 20 cm including barrel length 7

cm which recovered from the exclusive possession of accused Sk. Ashikul (kept conceal at the backside of waist) (fire arms was loaded with ammunition and seized the ammunition after unloading from the fire arms).

(ii) One iron made BHOJALI, total length 30 cm including 8 cm wooden butt (recovered & seized from the

possession of accused Raban Gorai).

(iii) One iron made sharp ending punching (fighter) (recovered & seized from the possession of accused Sk. Sarunur Khan).

(iv) One iron made SABAL length about 3.5 feet (recovered & seized from the possession of accused Sk.

Ramjan)

(v) Sketch map of Dacoity from the right side pocket of pant of accused Sk. Ashikul.

(vi) One Lylon rope about 30 ft. from the P.O.

I like to note here that due to odd hours of night no public witnesses were available at that time.

Hence, I do here by lodged complaint against the following accused persons namely -

(1) Sk. Ashikul (26 yrs) S/O- Sk. Ejahar of Vill-Hussaindih, PS- Jhalda, Dist-Purulia.

- (5) Tinku Das @ Chingri of Jhalda Anandabazar Hat tola, PS-Jhalda, Dist-Purulia.
- (6) Sk. Abbas of vill-Kantadih, PS-Jhalda, Dist-Purulia.
- (7) Sk. Imroj @ moja of vill-Kantadih, PS-Jhalda, Dist-Purulia.
- (8) Sanjay Karmakar of Jhalda School more, Mosina, PS-Jhalda, Dist-Purulia.
