In producing herewith one arrested accused person namely Radhanath Mahato (60 Y) S/o-Late Ghaltu Mahato of Vill-Kusumtikri, PS-Joypur, Dist-Purulia, State-WB under arrest along with seized articles as per seizer list i.e. 15 (Fifteen) bottles Illicit country spirit "DILKHUSH" strength 80 up measuring 600 ML each bottles of Rs. 35/- out of which one bottle taken as sample under proper seizure with label.

I ASI Manoj Kr Das of Joypur PS hereby lodged a written complaint against the above noted arrested accused person to the effect that on today (02/08/2019) at about 19:15 hrs when myself along with C/-120 Sandip Kumar, JC/-725 Rahul SM Patra were performed special mobile duty, as per my source information I reached at Kusumtikri village under Joypur PS and found that the above noted accused person selling country spirit "DILKHUSH" in his shop at his house. On seeing Police persons he conceal his presence at that shop, but on searching we able to trace out him and also to found that 15 (Fifteen) bottles of Illicit country spirit "DILKHUSH" which was kept conceal in a bag in his shop. On being asked he disclosed his name and address as noted above. On interrogation he stated that he was selling Id liquor to the local people in his shop Kusumtikri village after collecting from other side but on demand he failed to produce any valid documents in respect of selling such ID Liquor. So it is reasonable to believe that he was selling the Id liquor illegally without any documents. So I seized the same under proper seizure list & label duly signed by him and other available witness after taking 01 bottles of ID liquor as sample out of 15 bottles of ID liquor. During further interrogation he confessed his guilt as such I arrested him today 02/08/2019 at 19:35 hrs as the accused person is liable for prosecution u/s-46A (c) of the Bengal Excise Act 1909.

I therefore pray that a specific Case may kindly be started against the accused person namely Radhanath Mahato (60 Y) S/o-Late Ghaltu Mahato of Vill-Kusumtikri, PS-Joypur, Dist-Purulia, State-WB u/s-46A (c) of the Bengal Excise Act 1909.
