Nausad Shah of village-Mukundapur, P.S- Joypur, Dist- Purulia has committed theft of electricity U/S 135(1) (a) of electricity act 2003 subsequently amendment act 2007.

On 20.08.2019 at about 12.55 P.M. I Sri Nilanjan Kumar Mondal, AE & Station Manager, Joypur CCC along with 01.Ganesh Mahato, Gr1 TSH, Joypur CCC 02.Shibaram Mahato, HG TSH, Joypur CCC, 03.Sristidhar Mahato, HG.TSH, Joypur CCC, entered the premises of Mantu Shah, S/O-Lt. Nausad Shah of village-Mukundapur, P.S- Joypur, Dist- Purulia and found Mantu Shah, S/O-Lt.Nausad Shah was enjoying electricity unauthorizedly drawing power from the LTOH line of WBSEDCL through Green and yellow Aluminium plastic cable by means direct hooking to his house premises and connected load found 0.2 KW. As Mantu Shah, S/O-Lt.Nausad Shah committed theft of electric power. So, I seized the following articles after preparing the seizer list in presence of 01.Ganesh Mahato, Gr1 TSH, Joypur CCC 02.Shibaram Mahato, HG TSH, Joypur CCC, 03.Sristidhar Mahato, HG.TSH, Joypur CCC. The inspection team left the premises at 01.10 P.M.
