




The above named complainant

begs to state as follows :-

1...That the complainant is the legally married wife of accused No. 1 and their marriage was solemnised on 1. day of July 2014 at village Ropo within P.S. Joypur, District Purulia and within the jurisdiction of this court the said marriage was performed according to Hindu right and customs and according to ceremonics prevalent in their community including exchange of garlands putting in vermition home etc. and the said marriage is still subsistence.

- 2...That at the time of marriage as per demand of the accused persons the father of complainant had to pay a cash of Rs. 1,00,000/- along with other valuable articles and ornaments the value of those is Rs. 100000/-. But the accused persons were not happy and satisfied with either cash or articles so given to the accused persons.
- 3... That after marriage the complainant was taken to her matrimonial house by the accused persons and started to reside there as husband and wife with the accused No. 1 along with other accused persons in the same mess and house.
- 4... That in the mean time the complainant gave birth to two sons and a daughter namely, Prince Goswami, Raju Goswami and Saraswati Goswami.


5... That at the time of marriage my husband accused No. 1 was an unemployed youth but after four years of marriage my husband accused No. 1 has got service in Indian Railway.

6...That the complainant begs to submit that after marriage the accused persons started torture both physically and mentally but the complainant stayed at her matrimonial house bearing all such torture for a good days.

7.... That while the complainant was at her matrimonial home it was the daily routine of the accused persons to inflict the complainant torture both physical and mental even the accused persons did not hesitate to assault her and after four years of marriage the accused persons created presure upon the complainant to bring Rs. 2,00,000/-only by way of further dowry and contrary to that they will not allow the complainant to stay in their house any further and will not supply proper foods and cloths.

8...That the accused persons asked the complainant to leave their house so that they could arrange second marriage of her husband and it is there pleasure to fetch money by way of second marriage.

9...That on 16.6.2019 all the accused persons after assaulting the complainant confined her in a room and on hearing hue and cry the neighbouring people informed the said incident to the father of the complainant.





10.... That on 18.06.2019 the father of the complainant along with some near relatives and friends went to the house of the accused persons and requested them to keep the complainant properly but instead of behave well they snatched away all the ornaments of the complainant and draw the complainant and her father and near relatives who came there from their house and since then the complainant is residing at her father's house at village Ropo.


11... That there after the complainant lodged complaint against the accused persons before the Joypur P.S. but no action has been taken from their house.

12...That there after on 31.7.2019 the complainant informed the matter to to the superintendent of Police Purulia but no action has been taken from their ends.

while the complainant was staying at her paternal house at village Ropo under P.S. Joypur. All the accused persons along with some anti social Gundas came there and tresspassing the house they abused the complainant and assaulted her with fists and blows after falling her on the ground for which the complainant sustained serious pain injury on various parts of her body having seen the situation the father and mother of the complainant some how rescued the complainant from their clutches and hearing hue and cry the neighbouring people gathered and then they fled away but they threatened that they would kill the complainant when opportunity come.

14.... That the complainant is helpless lady having no income of her own and not in a position to continue her case at her own capacity.

15.... That the matter in very serious in nature and accordingly Police investigation is required.

In the circumstances it is prayed that your Honour may be pleased to send the petition of complainant to the officer-in-charge of Joypur Police Station treating the same as F.I.R. under Section 156(3) of the Cr.P.C. for investigation.
