Sub:-Prayer for starting a specific case against namely Sadhan Karmakar (57), s/o - Lt Prabodh Karmakar of Talajuri, PS - Kashipur, Dist-Purulia

Sir,

In producing herewith one accused person namely Sadhan Karmakar(57),s/o-Lt Prabodh Karmakar of Talajuri, PS-Kashipur, Dist-Purulia under arrest and the following seized articles under seizure list enclosed herewith:

- 1) Twenty six (26) sealed plastic bottles (CS) containing 375 ml each and labelled with DILSKHUSH.
- 2) One yellow nylon bag.
- 3) One white big polythin chat

I ASI Prasanta Dutta of Kashipur PS do hereby lodge this complaint regarding that today (02.08.19) at about 18.45 hrs during my evening mobile duty at Kapista more received source information over telephone that the above noted accused person has been selling CS liquor illegally and clandestinely in front of his residential house at Talajuri village under Kashipur PS. On receiving the reliable source information I communicated with O/C Kashipur PS over telephone and as per his instruction I along with JC/576-Avijit Goswami, NVF/560-Tapan Saren of Kashipur PS rushed to the spot to work out the information. On arriving to the spot at 19.00 hrs I apprehended the above noted person after a strong attempt and one customer seeing the Police party managed to escape. On close interrogation that apprehended person had disclosed his name & address as noted above. I asked him to produce any valid paper in support of selling that liquor but he failed to produce any legal paper or document in support for selling such liquor. Accordingly at 19.05 hrs I seized all those noted above after preparing proper seizure and labelled the seized articles duly signed by the accompanying party in the seizure list and the label. One bottle 375 ml liquor has been kept as sample taken from that seizure as sample which was also duly labelled and also took signature of the accompanying witness on seizure list and label. After this I arrested that accused person namely Sadhan Karmakar (57), s/o- Lt Prabodh Karmakar of Talajuri, PS-Kashipur, Dist-Purulia after preparing proper memo of arrest at 19.35 hrs.

Under the above facts & circumstances I pray before your honour that a specific case may kindly be started against the said accused person under proper section of law and arrange for investigation.
