I do hereby lodge a complaint empowered by enabling the Electricity act 2003 subsequently Electricity (Amendment) Act-2007 to the effect that Hamid Ansary S/O LT. Suleman Ansary, Vill.-Bhalagora Ghatghar , PO-Gourangdi, Dist-Purulia has committed theft of Electricity U/S-135(1)(a) of the Electricity Act 2003,(Amendment) Act-2007.

On dated 21.08.2019 I received a secret complain over telephone that Hamid Ansary S/O LT. Suleman Ansary, Vill.-Bhalagora Ghatghar , PO-Gourangdi, Dist-Purulia consuming electricity by means of hooking from nearest It line of WBSEDCL..

On the basis of said complaint at about 1.15 pm. I, Sri MrinalChowdhury, Divisional Engineer & Station Manager Kashipur Customer Care Centre, WBSEDCL along with,

- 1)Sri Dipak Kr. Bhowmik, SAE,Kashipur CCC
- 3) Sri Sanjoy Garain,OE Kashipur CCC.

Entered the premises of Sri Hamid Ansary, and found that he is consuming electricity dishonestly by means of hooking from nearest It network of WBSEDCL.

Total Load found approx 0.3 KW (fan-3 no, TV-1 no, CFL-5 no)

Then we disconnect his hooking line and seized the following articles.

- 1)Hooking wire with hooking device---6 mt.(approx).
- 2)Bulb with holder--1 no..

After preparation of proper seizure list The seizure list are prepared at the site and the representative of accused person refuse to sign in the seizer list. The inspection team left the above premises at about 01.50pm. The accused person has committed an offence U/S-135(i)(a) of the Electricity (Amendment) Act-2007 for illegal theft of electricity.

You are requested to take cognizance of the complaint and treat it as F.I.R and action may be taken as per rule.
