

Sub:-Prayer for starting a specific case against namely Badol Mondal (51), s/o-Lt Madan Mondal of Kendbedia, PS-Chhatna, Dist-Bankura

Sir,

In producing herewith one accused namely Badol Mondal (51), s/o-Lt Madan Mondal of Kendbedia, PS- Chhatna, Dist- Bankura under arrest and the following seized articles under seizure list enclosed herewith:

1) Twenty (20) liters ID liquor contained in a white plastic jarkin.

2) One yellow nylon bag.

3) One white big polythin chat

I ASI Giridhari Roy of Kashipur PS do hereby lodged this complaint regarding that today (27.08.19) at about 06.25 hrs received a source information over telephone that the above noted accused person has been selling ID liquor illegally and clandestinely at Huchuk para more of vill-Rampur under Kashipur PS. On receiving the reliable source information I communicated with O/C Kashipur PS over telephone and as per his instruction I along with C/847-Uttam Hazra, NVF/693-Jayanta Singh Sardar of Kashipur PS rushed to the spot to work out the information. On arriving to the spot at 07.15 hrs I apprehended the above noted person after a strong attempt and one customer seeing the Police party managed to escape. On close interrogation that apprehended person had disclosed his name & address as noted above. I asked him to produce any valid paper in support of selling that liquor but he failed to produce any legal paper or document in support for selling such liquor. Accordingly at 07.25 hrs I seized all those-noted above after preparing proper seizure and labelled the seized articles duly signed by the accompanying party in the seizure list and the label. One bottle of 250 ml liquor has been kept as sample taken from that seizure as sample which was also duly labelled and also took signature of the accompanying witness on seizure list and label .After this I arrested that accused person namely Badol Mondal (51), s/o- Lt Madan Mondal of Kendbedia, PS- Chhatna, Dist- Bankura after preparing proper memo of arrest at 07.35 hrs and observing all other formalities.

Under the above facts & circumstances I pray before your honour that a specific case may kindly be started against the said accused person under proper section of law and arrange for investigation.
