Respected Sir,

I, SI Ashoke Kumar Mahata S/O Sahadev Mahata of Vill - Pakbirra P.S - Puncha Dist- Purulia, Now posted as SI of Police at Kenda police station Dist- Purulia do hereby lodge complaint against arrested accd persons 1) Parikhit Mahali (54 yrs) S/O- Lt. Niranjan Mahali of village Chandra P.S - Kenda Dist- Purulia to the effect that On 08.08.19 acting on a secret source information myself along with ASI Tanmoy Chatterjee & C-1492 Dilip Ch. Gorain held raid at the house of above noted accused person and found that he selling of ID liquor at his house to the others. Seeing the Police, all the customer fled way and we managed to apprehended the accused persons. On being asked he failed to produce any valid licence /documents in respect of Storing and selling of ID liquor SO I seized 1) About 08 Ltrs. ID liquor in a plastic colossus 2) About 12 lirs. ID liquor in a plastic bucket under proper seizure list . and collect sample of ID liquor from above container and sealed and labelled by me in between 18.55 hrs to 19.05 hrs. There after I arrest the above noted accused person at 19:05 hrs. after disclosing him the grounds of arrest and observing all legal formalities. I also arranged to inform his family member about his arrest by police.

Hence I pray kindly treated as FIR as per law and to arrange for its investigation.
