I, SI Ashoke Kumar Mahata S/O Sahadev Mahata of Vill - Pakbirra P.S - Puncha Dist- Purulia, Now posted as SI of Police at Kenda police station Dist- Purulia do hereby lodge complaint against arrested accd persons 1) Biswajit Mahato (45 yrs), S/O- Lt. Madan Mahato of village Panipathar P.S - Kenda Dist- Purulia to the effect that On 08.08.19 acting on a secret source information myself along with C-1492 Dilip Ch. Gorain & NVF- 673 Rabi Sing Sardar of Kenda P.S Dist- Purulia held raid at the house of above noted accused person and found that he selling of country Sprite to the others at his sweet and tea stall at Panipathar More. Seeing the Police, all the customer fled way and we managed to apprehended the accused persons. On being asked he failed to produce any valid licence /documents in respect of Storing and selling of country Sprite. SO I seized 1) 40 bottle of country Sprite styled as DIL-KSUSH containing 600 ml in each bottle under proper seizure list. and collect 1 bottle of country Sprite from seized 40 bottles as sample and sealed and labelled by me in between 20:15 hrs to 20:25 hrs. There after I arrest the above noted accused person at 20:25 hrs. after disclosing him the grounds of arrest and observing all legal formalities. I also arranged to inform his family member about his arrest by police.


Hence I pray that kindly start a case against the accused person as noted above U/S 46 A(C) BE Act.
