In producing here with one arrested accused person namely Sitaram Mahato (62 yrs) ,S/O- Lt. Chaitu Mahato of village Ralibera P.S - Kenda Dist- Purulia and seized articles 1) 10 (ten) liter ID liquor and 375 ML I.D liquor as sample, I ASI Swapan Kumar Gorain (43 yrs) S/O- Madhab Chandra Gorain of Vill+P.O- Pithajore P.S - Purulia (M) Dist- Purulia, Now posted as ASI of Police at Kenda police station Dist- Purulia beg to report that today 17.08.19 in course of evening mobile duty, acting on a source information myself along with C/1255 Ajay Kr. Bauri & NVF- 673 Rabi Sing Sardar of Kenda P.S Dist- Purulia held raid at the house of above noted accused person and found that he storing and selling of I.D liquor to the others at his house at Ralibera village . Seeing the Police, all the customer fled away and we managed to apprehended the accused person who is the stockist and seller of I.D liquor. On being asked he failed to produce any valid licence /documents in respect of Storing and selling of I.D liquor. SO I seized 1) 10 (Ten) Litters I.D liquor contain in a white colour Plastic jerican under proper seizure list and collect 375 M.L I.D liquor in a bottle as sample from the above noted jerican. and sealed and labelled by me in between 17:15 hrs to 17:25 hrs. There after I arrest the above noted accused person at 17:25 hrs. after disclosing him the grounds of arrest and observing all legal formalities. I also arranged to inform his family member about his arrest by police.

Hence I pray that kindly start a case against the accused person as noted above under proper section of law.
