In producing here with one accused person Parmeswar Nag(35) S/O Narayan Ch. Nag of Indkuri near Hari Mandia Bo village- Indkuri near Hari Mandir ,PS- Manbazar, Dist- Purulia along with following seized articles vizarticles viz-

- (1) 20 (Twenty) Ltrs ID liquor within a Jarikan
- (2) 13 pieces plastic glass
- (3) Sale proceed of Rs- 95/-

I S.I. Mahadeb Rana of Manbazar PS do here by lodged a complaint against accused namely Parmeswar Nag (35) S/O Narayan Ch. Nag of village- Indkuri near Hari Mandir, PS-Manbazar, Dist-Purulia to the effect that today (27.08.19) at 18:05 hrs. I received a telephonic information from a reliable source that one Parmeswar Nag(35) S/O Narayan Ch. Nag of village-Indkuri near Hari Mandir ,PS- Manbazar, Dist- Purulia was stocked ID liquor illegally and selling the same to hike price for his personal gain then I noted this information in GD vide Manbazar PS GDE No- 1020 Dtd 27.08.19. I informed the matter to O/C Manbazar PS and as per order of O/C Manbazar PS myself along with C/905 Anil Patrra, C/1042 Prakash Ch. Mandal rushed to the spot for raid by Govt. vehicle. At about 18:25 hrs. myself along with force reached at Indkuri More neara Hari Mandir and held raid in the house of Parmeswar Nag and found that said house owner selling ID liquor at his own house and Seeing the police party some persons fled away and said Parmeswar Nag tried to concealed himself but we are able to apprehend him and also detained him. I asked him to produce valid license or valid papers for selling ID liquor, but he failed to produce any valid license or documents for possessing / selling the same. So I arrested the above noted accused person informing the ground of arrest and seized the above mentioned articles after proper seizure list duly sign by accused person and available witnesses.

Hence, I therefore pray that a specific case may kindly be started against arrested accused person Parmeswar Nag(35) S/O Narayan Ch. Nag of village- Indkuri near Hari Mandir, PS-Manbazar, Dist-Purulia as per law and arrange for its investigation.
