I do hereby lodge a complaint empowered by enabling the Electricity act 2003 subsequently Electricity (Amendment) Act-2007 to the effect that Sri Mir Nur Hossain S/O- Mir Nur Islam of Village- Manbazar Muslima P.O- Manbazar P.S.- Manbazar, Dist - Purulia, has committed theft of Electricity U/S 135(1)(b) of the Electricity (Amendment) Act-2007.

On dated 28-08-2019 at about 2:15 Pm, Sri Swarup Mandal, Station Manager, Manbazar Customer Care Centre, WBSEDCL along with,

entered the premises of Mir Nur Hossain, S/O- Mir Nur Islam of Village- Manbazar Muslima P.O- Manbazar, P.S.- Manbazar, Dist - Purulia and inspected his/her premises and found that he was enjoying electricity unauthoritarily i.e bypassing of energy meter by cutting incoming service wire.

During inspection, theft of electricity was found, i.e., he/she was using electricity dishonestly U/S 135(1)(b) was detected. It was also found that he/she was using the following electrical equipments -
