Dear Sir,

I do hereby lodge a complaint empowered by enabling the Electricity act 2003 subsequently Electricity (Amendment) Act-2007 to the effect that Sri Mirnur Hossain S/O- Mirnur Islam of Village- Manbazar Muslimpara, P.O- Manbazar, P.S.- Manbazar, Dist - Purulia, has committed theft of Electricity U/S 135(1)(b) of the Electricity (Amendment) Act-2007.

On dated 28.08.2019 at about 2.15 PM, Sri Swarup Mandal, Station Manager, Manbazar Customer Care Centre, WBSEDCL along with,

entered the premises of Mirnur Hossain, S/O- Mirnur Islam of Village- Manbazar Muslimpara, P.O- Manbazar, P.S.- Manbazar, Dist - Purulia and inspected his/her premises and found that he was enjoying electricity unauthorizedly i.e bypassing of energy meter by cutting incoming service wire.

During inspection, theft of electricity was found, i.e., he/she was using electricity dishonestly U/S 135(1)(b) was detected. It was also found that he/she was using the following electrical equipments -

- 2) One nos TV

The seizure list is prepared at the site and the accused person refused to sign in the seizure list. The inspection team left the above premises at about 2.40 PM on dated 28.08.2019. The accused person has committed an offence U/S 135(1)(b) of the Electricity ACT 2003 (Amendment) Act-2007.
