Purulia, for disrupting plant operation, involvement in anti-plant activities and violence on plant Security and Staff.**

The above workers had remained off work since 15.08.2019 without any intimation to the plant and its management. (They issued unlawful demanded duty given on weekly off days)

Mr. Ashis Majhi and Bijay Krishna Bhattacharya out of six today morning despite not being on duty, they forcefully entered the plant by threatening the Security Guards and accessed the mechanical maintenance area. They stopped the Contractor appointed by the plant management to do his job around 9.00 am near E.S.P area inside factory premises. When the plant staff namely, Saurav Agarwal, Falguni Ojha, Samit Mukherjee, Gurdeep Ghai, Milan Gorai, Roop Kumar Patra and others went to intervene on same place around 9.40 am and told them not to do all this they started abusing and threatening them. They first abused pushed Saurav Agarwal. When Falguni Ojha tried to stop them from pushing Saurav Agarwal, they caught hold of Falguni Ojha and beat him severely with punch and kicks. They even tore his clothes.

The information of this incident was immediately given to Neturia Police Station, Trade Union Leaders namely Prashanta Chakraborty of CITU and Ananda Bauri of INTTUC by Falguni Ojha.
