I do hereby lodge complaint empowered by enabling the IE Act 2003 subsequently (amendment at 2007) to the effect that Amiya Bouri, s/o- Lt. Santosh Bouri was enjoying electricity unauthorisally by means of direct hooking from nearest LTOH line of WBSEDCL.

has committed theft of electricity u/s 135 (1)(a) of the electricity act 2003 duly amended on 2007.

On today (20-08-2019) at about 15:20 Hrs I Gotirmoy Dass Station Manager, Saltore Customer Care Center along with:-

Entered the premises of Amiya Bouri, s/o- Lt. Santosh Bouri of Village: Bora(Bagalkuli) Ps. Neturia Dist. Purulia and inspected his/her premises. During inspection theft of electricity was detected i.e. he/she was using electricity dishonestly by drawing illegal hooking from nearest LTOH line of WBSEDCL i.e. u/s 135 (1)(a) was detected.

From the above arrangement he/she was using the following electrical equipments:-
