Sub: Prayer for starting a specific case.

Respected Sir,

In producing herewith one accd. person namely Fulchand Tudu (34) S/O- Lt. Sanatan Tudu of Vill-Sahebdanga, PS-Neturia, District- Purulia with seizure of 19 pcs. Sealed bottles of Dil Se country spirit containing 375 ml each which were seized under proper seizure list.

I beg to submit that today (27.08.19) at 18:35 hrs while myself, SI Kalyan Kumar Sakha, with force were performing anticrime evening mobile duty near Sarbari more that time received a source information that one Fulchand Tudu (34) S/O- Lt. Sanatan Tudu of Vill-Sahebdanga, PS-Neturia, District- Purulia has illegally stocked liquor in his tea stall at Sahebdanga village under PS- Neturia & selling the same. On receiving the information, I informed the matter to you and as per your instruction, I along with force proceeded to Sahebdanga village to work out the information. At 18.55 hrs after reaching at Sahebdanga village held raid in the tea stall of Fulchand Tudu and found that he was keeping / selling liquor which were kept in his tea stall, on demand Fulchand Tudu failed to produce any valid documents/License in respect of selling of liquor as well as nobody turned up to produce any valid documents. As such he committed offence u/s 46 A(c) B.E. Act and he was arrested U/S-67 BE Act and also 19 pcs. Sealed bottles of Dil Se country spirit containing 375 ml. each which were seized under proper seizure list duly signed by witnesses and labeled at the time of arrest. During arrest the ground of arrest was duly notified, issued arrest memo u/s 50 Cr. P.C. and handed a copy of the same to arrestee.

The arrested accd. namely Fulchand Tudu (34) S/O- Lt. Sanatan Tudu of Vill-Sahebdanga, PS-Neturia, District- Purulia has committed offence u/s 46 A(c) B.E. Act, 1909 for unauthorized possession and sale of liquor.

It may note here that during raid (1) C/1001 Soumendu Das (2) C/66 Kameshwar Pandey and (3) C/1260 Santosh Soren, all of Neturia PS accompanied me.

Under the above facts and circumstances I therefore pray that a specific case may kindly be started against Fulchand Tudu (34) S/O- Lt. Sanatan Tudu of Vill-Sahebdanga, PS-Net ria, District- Purulia under proper section of law.
