I do hereby lodge complaint empowered by enabling the electricity act.-2003 subsequently electricity (Amendment) act.- 2007 to the effect that on today (02-08-19) at about 16:15 hrs he was enjoying electricity unauthorisedly i.e. by passing the energy meter and due to this reason he has committed theft of electricity U/s 135 of the electricity (Amendment act.- 2007) on (02-08-19) I. Sri Gotirmoy Dass, Station Manager, Saltore CCC, WBSEDCL

Entered the premises of Sri Jitendranath Dhibar, Vill. Mahuda P.S. Neturia Dist- Purulia, having Consumer No. 242106493, Meter No. TS272793 and inspected his/her premises. During the inspection theft of electricity was detected i.e. by passing the energy meter i.e. U/S135(I) (b) was detected. The details of passing the arrangement was damage installation of the incoming wire and top 2 (two) piece of wire by which electricity directly flow to his house without energy registration in WBSEDCL energy meter.

From the above by-passing system he/she uses the following electrical equipments.

- ① Electric Fan (80W) - 06 nos
- ② Freeze (120 W) - 01 nos
- ③ Colour T.V. (150W) - 01 nos
- ④ Water Pump (373W) - 01 nos, ⑤ LED (12 W) - 09 nos

Out of which I seized the following.

Energy meter vide meter No- TS272793 along with by pass arrangement with 01 ft service cable & 32 A cut out set.

Seizure list was prepared at the site and accused person refuse to sign/signature <sup>but signed on entry notice</sup>. The inspection team left the premises at 16:35 hrs on 02-08-19. The accused person has committed an offence U/S135(I) (b) of the electricity act.-2003 subsequently electricity (Amendment) act.- 2007.

You are requested to take cognizance of this complaint & treat it as F.I.R. and action may be taken as per rule.
