Entered the premises of Sri Jitendranath Dhibar Vill. Mahuda P.S. Neturia Dist- Purulia, having Consumer No. 242106493 Meter No. TS 272793 and inspected his/her premises. During the inspection theft of electricity was detected i.e. by passing the energy meter i.e. U/S135(I) (b) was detected. The details of passing the arrangement was damage installation of the incoming wire and top 2 (two) piece of wire by which electricity directly flow to his house without energy registration in WBSEDCL energy meter.

From the above by-passing system he/she uses the following electrical equipments.

- ① Electric Fan (80W) - 06 nos
- ② Freeze (120 w) - 01 nos
- ③ Colour T.V. (150W) - 01 nos
- ④ water Pump (373W) - 01 nos, ⑤ LED (12 W) - 09 nos

Out of which I seized the following

Energy meter vide meter No- TS 272793 along with bypass arrangement with 01 ft service cable & 3.2 ft cut out set. Seizure list was prepared at the site and accused person refuse to sign/signed. The inspection team left the premises at 16:35 hrs on 02-08-19. The accused person has committed an offence U/S135(I) (b) of the electricity act-2003 subsequently electricity (Amendment) act- 2007.
