Sir,

With reference to the above-mentioned subject, this is to inform you that Raid Programme conducted by the Officials of the Office of the ADM & DL&LRO, Purulia on 01.08.2019; it is found that there are instances of unauthorized stock of sand in Mouza-Sonaijuri (JL No. 39). After verifying concerned mouza-map and physical enquiry, it is verified that there are six no. of stocks with quantity of 12940 cft (approx), 10944 cft (approx), 8820 cft (approx), 9408 cft (approx), 6720 cft (approx) and 2700 cft (approx) [Total 51532 cft] sand is stocked in RS plot no. 409 and the sand is stocked in two areas of RS plot no. 884 with quantity of 4896 sq. ft (approx.) and 2812 sq. ft (approx.) [Total 7708 cft]. The above-mentioned plots are adjacent to Sonaijuri Gram Panchayat.

Under such circumstances, you are requested to make arrangement for guard the stock of sand in the above-noted plot until disposal of the issue and to take action as per provision of law.
