

- 6. Offences:-U/S ,341 , 323,326,325 506/34 I.P.C.

The above named complainant begs to state as follows:-

1----That your petitioner , the witnesses and the accused persons are the residents of the same village Shyampur , under P.S. Purulia (M) and within the Jurisdiction of this ld. Court . The accused person is the close neighbour of your petitioner.

2.---That all the accused persons are the residents of village Shyampur used to run country liquor shop in the middle portion of the village and caused nuisance in the village by the drunkard and the accused persons .

3----That on the date of occurrence ,at about 4.00 P.M. accused Basudeb Singh has drinking liquor in the shop of accused Dhiren Singh and hurled slung and defamatory words pointing to the females of that village and using abusive languages towards them . At this, your petitioner protested the illegal and abusive words hurled towards the females of that village and warns the owner of the liquor shop to stop the same . There was hot altercations between the petitioner on the one side and the shop owner , his son, wife and daughter and accused Basudeb sing on the other . During the midst of altercation all the accused persons encircled the petitioner forcibly caught hold the petitioner




and accused Guddu Singh started to assault the petitioner on her head by a KHUNTI in order to kill her causing greavious bleeding injury on her head . Accused Dhiren singh also assaulted the petitioner on her head by a KETTLEE indiscriminately . Your petitioner was fall down on the spot and there after accused Thanda Singh , Janaki Singh and Rekha Singh also assaulted the petitioner by fists , blows and kicks all over her body . The witnesses Shobha Singh and Buri Mahato rushed to the spot and rescued the petitioner from the clutches of the accused persons . There after the accused persons saying that today or tomorrow we will finish the petitioner from the world and leave the place hurriedly .

4----That the other women of that village rescued the petitioner from the clutches of the accused persons and narrated every thing to the villagers.

5----That thereafter, by the help of the villagers the complainant was brought to local P.S. The complainant narrated the incident to the police Officer on duty. The police officer on duty sent the petitioner immediately to Sadar hospital for her treatment . The doctor of Sadar hospital Admitted the injured as indoor patient and she was treated for 3 / 4 days and discharged .

6----That there after your petitioner lodge written complaint before the local police station but the officer on duty refused to receive the same On further approach your petitioner came to learn that till yet no specific police case whatsoever has been started against the accused persons by the police best known to them . Under such circumstances your petitioner finding no other alternative but to knocked the





door of the Superintendant of police Purulia on 03-02—2019, but nothing has been done from his good office.

7---That your petitioner is a very poor man having no source of income whatsoever . She is not in a position to conduct the case on her own expense. More over , there are some technical and legal aspects involved in this case which also requires considerable money and machinery . For all these , it is highly desirable and prayed that this case should be converted to a police case .

It is prayed that your honour may be graciously pleased to direct the Officer in Charge Purulia (M) Police station to investigate the case in accordance with law, treating the same as F.I.R. as contemplated U/S 156(3) Cr. P.C.
