

The humble petition U/S 156 (3) of the Code of Criminal Procedure 1973 on behalf of the petitioner above named;

Most respectfully begs to state:

- That Bedana Mahato Wife of Bholanath Mahato, is a house-wife and residing at Village and P.O: Ghonga, P.S-Purulia (M), District-Purulia, and it is within the jurisdiction of your Honour's Court.
- 2. That on 16/06/2019, at about 7 p.m., when the petitioner was alone at her house, all the accused persons all in a body trespassed into the








house of the petitioner and started to beaten her up, and drag her by holding her hair and throw her on the ground .

- 3. That at that time, the accused persons 1, 6 and 7, namely Brindaban Mahato, Sanjib Mahato and Ajit Mahato hit the petitioner by a lathi on her head and on the right shoulder with an intention to finish her life. The petitioner sustained severe injury on her head.
- 4. That after such assault the accused persons drag her out from the house and tied the petitioner with an electric poll and started beating her.
- 5. That the accused persons threw away the utensils of the petitioner on the road and damaged these articles.
- That on hearing her cries the local witnesses and the sons of the petitioner gathered there and seeing them the accused persons left the spot.
- 7. That at about 10.30 p.m. the younger son of the petitioner namely Dhananjay Mahato took the petitioner to the Purulia Sadar Hospital and after preliminary checking the doctor admitted the petitioner in the hospital and after three days, on 19/06/2019 petitioner was released from the hospital.





- 8. That after being released from the hospital, on the same day,i.e., 19/06/2019 the petitioner went to Purulia (M) P.S but the police refused to take any action against the accused person .
- 9. The matter was reported to Superintendent of Police, Purulia on 05/07/19, but police is yet to state any case.
- 10. That being dejected, your petitioner intends to file this instant application.
- 11. That your petitioner is a poor woman and this case requires through police probe including examination of witnesses etc.

It is, therefore, prayed that your Honour may graciously be pleased to direct the police of Purulia (Mufassil) P.S to treat this petition as F. I. R. and to cause investigation in respect of the alleged incident.

And for which act of kindness, your petitioner, as in duty bound shall ever pray.
