The above-named complainant begs to state as follows:-

1.---That the complainant, Accused persons and witnesses are the resident of village Mahali Tora, under P.S. Purulia (M), District Purulia (W.B.)

2.---That the complainant is by profession Driver and also peace living, law abiding person.

3.---That on 21-06-2019, corresponding to 5th day of Ashar 1426 B.S. at about 2.00 to 2.30 A.M. the complainant as usual was sleeping in his room with family members when suddenly the accused namely Bhaskar Mahato son of Jagannath Mahato and his men entered into the house of the complainant armed with different types of deadly weapons like Tangi, Iron Rod etc. in their hands. All on a sudden accused person started abusing the complainant, then the complainant protested the illegal act of the accused person but they did not pay any heed to the protest of the complainant. Suddenly the accused No.1 (Bhaskar Mahato) assaulted the complainant on his right hand by Iron Rod. AS a result of which he sustained bleeding injury. Due to such injury the complainant fell down. Then the accused (Bhaskar Mahato) snatched a Golden neckless from the neck of the complainant's ~~brother~~. Then the complainant makes a noise by saying BANCHOW BANCHOW / "Save us - Save us". Hearing the news the witnesses came there and save the complainant from the hands of the accused person. The witnesses named above now

^{now} ~~the~~ the incident. Then the accused persons left the place giving threatening with dire consequence. And for the complainant sustained loss of Rs.40,000/- (Rupees Forty thousand) and losses of blood.

4.---That there after the complainant went to Purulia (M) P.S. to reported the matter to Duty Officer of Purulia (M) P.S. and went to Purulia Sadar Hospital for treatment.

5.---That after some days the complainant went to P.S. to inquired about his complaint and the complainant came to learn that the police personal of Purulia (M)P.S. have not start any case against the accused person. And there after complainant informed the matter to S.P. Purulia but off no good.

6.---That the accused person have committed Offence U/s 447,323,324, ~~379~~^h,379/34 I.P.C.and they are liable to be punished accordingly.

7.---That the complainant is one ^{Driver} ~~business man~~ and could not effort to expense of the case for which the seek justice.

It is therefore prayed before your honour would be pleased to direct the Officer-in-charge of Purulia (M) for investigation of the case against the accused person by treating the complaint as F.I.R. as provided U/s 156(3)C.P.C.
