Sir,

With reference to the above-mentioned subject, this is to inform you that as per Joint Raid Programme conducted by the Additional Superintendent of Police, Purulia and Officials of the Office of the ADM & DL&LRO, Purulia on 30.07.2019, it is found that there are instances of unauthorized stock of sand in Mouza-Kotlui (JL No. 46) and Mouza-Ketika (JL No. 05). After verifying concerned mouza-map and physical enquiry, it is verified that there are 5320 sq. ft (approx.) sand is stocked in RS plot no. 115 and the sand is stocked in two areas of RS plot no. 113 with 3456 sq. ft (approx.) and 2880 sq. ft (approx.) in Mouza- Kotlui (JL No. 46) and there are 11700 sq. ft (approx.) sand stocked in RS plot no. 3138 in Mouza- Ketika (JL No. 05).

Under such circumstances, you are requested to take action as per provision of law.
