Sir,

With due respect. I Anup Kumar Bhagat S/O Bhola Prasad Bhagat Chaibasa Road near usha machine, Purulia would like to inform you about the incident held on 01-08-19 near about 9:00 P.M near Akash Sagar North Lake Road Purulia. My Son Chirag Raj Bhagat along with his friends Swastik Das, Dipesh Agarwal, Shivam Singh & Bidya Banerjee were moving towards Raghobpur more in their two wheelers. From opposite side direction Harshit Sukhla, Soumik Goswami they intentionally hit my son's scooter's handle & my son & his friend Bidya Banerjee they both fell down from the scooter. When my son asked them to stop & was about to go for first aid; the culprits (Harshit Sukhla, Soumik Goswami) they called some of their friends & started hitting my son & his friends. They picked up Iron Rod & stones from road side to hit my son. My Son got injured & he started bleeding from his mouth & nose. Suddenly there reached a Police Van

and the culprits ran away from there.

Police thereafter send my son & his friends to hospital for Emergency first aid. Still My Son has been referred for C.T Scan & his reports are yet to come and my son is not in his normal condition & is not well. I have to take him for medical treatment outside Purulia.

Kindly take this FIR and please take strict actions against the accused culprits Sounik Goswami, Harshit Sukla and fifteen others involved.
