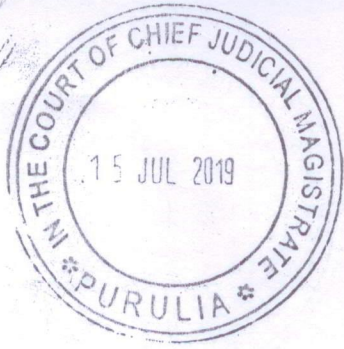

Since after two years of marriage and lastly on 14.06.2019 at about 08:00 A.M..

F. Place of Occurrence:

At the house of the accd. persons at Kasai Danga ward no 9, P.O. Purulia, P. S. Purulia (T), District Purulia, and at the fathers house of the complainant at Ranibandh Para, ward no 8, P.O. Purulia, P.S.- Purulia (T), Dist- Purulia.

The above name complainant begs to state as follows:-

1. That your complainant and witnesses has been residing under P.S.-Purulia (T), Dist.- Purulia and the place of occurrence is under P. S. Purulia (T) and within the jurisdiction of this Ld. Court.
2. That your petitioner was married with one Md. Aslam @ Sk. Aslam, S/O Md. Usman Khan resident of Kasaimohalla, ward No 8, P.O. Purulia , P.S. Purulia (T), District Purulia on dated 09.09.2010 as per Muslim "Sariat" and customs prevalent in their society.
3. That after solemnization of marriage the accd No 1 took your petitioner to his residential house at Kasaimohalla ward no 8 P.S. Purulia (T), District Purulia and started to live there as husband and wife. After expiry of two years of peaceful matrimonial life the accd No 1 and his family members started to demanding further dowry of Rs 20,000/- from your petitioner with an excuse that the accd. no 1 intends to set up a business of "Kabadi".
4. That on this your petitioner started that her father is a poor and financially handicapped personality and at the time of marriage a sum of Rs. 30,000/ cash one wrist watch, one By cycle, one Gold ring which approximately of Rs.20,000/along with utensils was provided to the accd. No 1 as per his demand. And now at present petitioner's father is not capable to provide any further dowry. At this the accd. Persons became furious and assaulted your petitioner with fist and

- Persons became furious and assaulted your petitioner with fist and blows and drove her out of the house along with her three minor daughters includes lap baby.
5. That reaching at the father's house at Ranibandh Para, ward no 9, P.S. Purulia (T), District Purulia your petitioner narrated or explain the entire facts to her mother, uncle and father and prayed for money as demanded by the in laws but they showed their inability.
  6. That after a few days all of a sudden on dated 14.06.2019 the husband of your petitioner along with other accd. persons in the morning at about 08:00 A.M. came to the fathers house of your complainant and started to abuse your complainant at this aged senile father of your complainant raised objection but the accd persons did not pay any heed over the words of the father of the petitioner. On the contrary the husband of your petitioner became furious and started to assault your petitioner by fits and blows and caught hold the locks of hair of your complainant and gave jerk as a result your petitioner fell down on the earth and kicked your petitioner over her body and threatened her the he shall sold the minor children and if objected your complainant shall face the dire consequences.
  7. That your petitioner shouted and neighbors came in rescue but the accd. persons fled away with a threatening of murder them.
  8. That thereafter your complainant went to the local P.S. at Purulia (Town) for reported the incident against the above said accd. persons but due to reason better known to the police official of the said P.S. did not take any action of the said complain.
  9. That thereafter on 18.06.2019 your-complainant informed the matter to the Superintendent of Police of Purulia but till today not any action has been taken by the police of Purulia (T) P.S. against the accd.
