Sir,

I, Tapas Dutta, Sub-Inspr. of Police, DEB, Purulia, do here by lodge complaint being produced the accd person namely Ritesh Jhawar(38yrs.) s/o Lt. Kedarnath of B.B.Das Road by lane, Ward No.14, PS Purulia(T), Dist Purulia along with the following seized articles (i) 07 (seven) domestic LPG cylinders of HP company fully loaded with LPG (ii) 01 (one) domestic LPG cylinders of HP company which is empty (iii) 01 (one) domestic LPG cylinder of HP company partially loaded with LPG (iv) 02 (two) domestic LPG cylinders of INDANE company fully loaded with LPG (v) 01 (one) domestic LPG cylinder of INDANE company partially loaded with LPG (vi) 04 (four) domestic LPG cylinders of INDANE company those which are empty (vii) 02 (two) commercial LPG cylinders of INDANE company those which are empty & (viii) 01 (one) apparatus having length of approx 9.5 cm, appearing to have been made of copper & steel used for re-filling gas from one to another cylinders to the effect that today on 26.08.19 on the basis of secret and credible information I, along with W/C 88 Pradyut Mandal, HG/1427 Benimadhab Char had been to Purulia(T) PS and submitted one requisition to OC Purulia(T) PS for rendering assistance and the credible information at Purulia(T) PS at 15:05hrs. has been noted vide Purulia(T) PS GDE No.1390 dtd.26.08.19 at 15:15 hrs. Thereafter we along with ASI Tapas Patra and force of Purulia(T) PS as well as DEB personnel left for B.B. Das road by lane under Purulia(T) PS to work out the information. On arrival near B.B.Das road by lane at about 15:40hrs to work out the information, I asked two local people viz. (1) Sanjoy Kr. Singodia (50yrs-By profession Municipality contractor) s/o Lt. Kishorilal Singodia of B.B.Das Road, Ward No.14, PS Purulia(T) & (2) Sibusao (25yrs-By profession Caterer) s/o Gopal Sao of Old Police Line More, Ward No.10, PS Purulia(T), Dist Purulia to assist us for holding raid, search and seizure in the house of one Ritesh Jhawar s/o Lt. Kedarnath of B.B.Das Road by lane, Ward No.14, PS Purulia(T), Dist Purulia. Prior to holding raid in the house, we noticed huge nos. of domestic / commercial LPG cylinder kept inside the house along with apparatus which is used for refilling LPG from one to another cylinder. The owner namely Ritesh Jhawar was asked to produce valid documents / license for running his business in respect of possessing such domestic / commercial LPG cylinders and also such business of refilling, but the owner failed to produce any valid documents / license for running such illegal business. Thereafter myself along with accompanied officers and force along with the active assistance of above noted two local witnesses as above held raid in the house of Ritesh Jhawar s/o Lt. Kedarnath

of B.B.Das road by lane, after observing all formalities relating to search and seizure in between 16:05 hrs and 17:05 hrs.

As such I seized the articles with proper labeling in presence of local witnesses and police witnesses under proper seizure list from the house of Ritesh Jhawar in between 16:05 hrs and 17:05 hrs.

Sri Ritesh Jhawar s/o Lt. Kedarnath Dutta failed to produce any valid documents / papers for running such business hence he violated the provisions laid in rule 3 of West Bengal Cooking Gas (Licensing & Control order) 1985. Hence he has committed an offence punishable u/s 7(i)(a)(ii) of E.C.Act'1955. It appeared that if he is not arrested now he may tamper with evidences and he is also very likely to hinder investigation. So the said Ritesh Jhawar s/o Lt. Kedarnath of B.B.Das Road by lane, Ward No.14, PS Purulia(T), Dist Purulia was arrested after informing him the ground of arrest, issued Memo of Arrest to him in presence of his relative duly signed by him at 17:15 hrs.

In course of local enquiry it revealed that said Ritesh Jhawar is running clandestine business of LPG Gas Cylinder and also selling LPG after refilling in other cylinder since long without having any authority or license and only for causing his wrongful gain and causing loss of revenue to Govt.


I therefore request you to start a case u/s 7(i)(a)(ii) of E.C.Act'1955 against accused Ritesh Jhawar aged 55 yrs. s/o Lt. Kedarnath of B.B.Das Road by lane, Ward No.14, PS Purulia(T), Dist Purulia.

As per order of Dy.SP(DEB), Purulia SI Sajal Mishra of DEB, Purulia will investigate the case.
