This fact is for your kind information and for taking the necessary action through the mode of an F.I.R., that, I, BIKRAM MOOKERJEE, Special Revenue Officer – II & Block Land & Land Reforms Officer, Raghunathpur – I, went today, i.e., on 28/08/2019 at around 1.00 PM to 1.30 PM on the raid program in the areas of Joychandi Pahar.

There we saw a huge portion of land unearthed and two laborers were still working on it, and I started to talk to them on this issue, like, with whose permission they were doing so. Then they called the person, named Jiten Sukla aka Chiku Sukla over phone and asked him to come.

Mr. Sukla came along with an assistant of his, and he right from the beginning started to argue by asking that on what basis of authority we were on the raid program. When I gave him my official identity, he accepted that he's in-charge of the excavation, but in no way he accepted the fact, that, those were the unauthorized extractions of earth done by him. He told his men to not to listen to the government authority.

When I did let them know that I had already informed the police to arrive, he immediately told his men to run away immediately.

When I began to chase them, then they pushed me hard in a big hole (Which was excavated by them) and I got injured.



After these, I am coming here in the Police Station to lodge the F.I.R.
