Sir,
I invite your attention to the fact that I am a teacher of Gumra C.B.A. High School, Taratari, Santuri.

on 03.08.2019 at around 10.40 A.M. while I was coming to attend my school, suddenly two motor Bikers (one was driving the bike and another was pillion rider) with helmets on their heads intercepted me near Lalgarh village, few cubits away from Bhutnath temple and physically assaulted me and told me in specific terms that if my husband does not withdraw the case now pending in Ld. ~~Dist~~ Dist. Judges Court, Khatra, Bankura, against Riya Paramanik they would implicate me and my husband in false criminal cases and even could murder us.

I got tremendously disturbed and panicky and the bikers, after the incident, ran away in high speed.

I had been to Muradik B.P.H.C. on the same day and went back home at Neamatpur,

As I was not mentally well and panicky as well, I could not come to your P.S. readily.

I, therefore request you to kindly diarise the information and take necessary steps for my protection and find out the culprits.
