I do hereby lodge complaint empowered by enabling The Electricity Act-2003,

Entered the premises of Pradi P Mandal, S/O- Fatik Mandal

and inspected his/her premises. During inspection theft of electricity was detected i.e. he/she  
was using electricity dishonestly by drawing illegal hooking from the nearest L.T.O.H line of  
W.B.S.E.D.C.L. i.e. U/S 135 (I) (a) was detected.

From the above arrangement he/she was using the following electrical equipments

- 1) 1/2 HP Motor - 375 watt
- 2) Refrigerator 1 no - 160 watt
- 3) Bulb 1 no - 100 watt
- 4) CFL 2 nos -  $(2 \times 18) = 36$  watt
- 5) Fan - 2 nos -  $(80 \times 2) = 180$  watt
