1...That your complainant is a legally married wife of the accused no.1 and marriage between the complainant and accused no.1 was solemnized on 18.06.2010 as per

Hindu rites and customs prevails in their society at the parental house of the complainant at Village – Senabona, P.O. Hensla, P.S. Arsha, District – Purulia and within the jurisdiction of this Ld. Court.

2...That the marriage between the parties was result of a negotiation and it was a arranged marriage.

3...That at the time of marriage the father of the complainant gave Rs. 1,00,000/- (Rupees one lack only) in cash, golden ornaments worth 40 Grams (Four Bhoris), furniture's, and other household articles as per demand of the accused persons i.e. accused no. 1 to 7.

4...That after marriage the accused persons (Accused No.1 -7) took the complainant to their house and the complainant also came to her matrimonial house at House No. 10/10, Benachity, P.S. Arabinda, and Durgapur713213 with a dream to start a happy conjugal life.

5...That after few months of marriage the Complainant was subjected to immense Physical and mental torture by Accused Persons in lieu of extra demand of dowry worth Rs. 1, 00,000/-. She was never accepted with love and dignity by the Accused No.1 and his family members i.e. the accused No.2 to 7.

6... That the caustic comments and torture by way of both physical and mental by the Accused persons become unbearable to the petitioner day by day. It was become the practice of the Accused No.1 to beat the Complainant off and often on by raising very petty house hold issues.

7... That the Complainant bears all such tortures inflicted by the Accused Persons (No.1-7) with a hope that all such things will be normalized in the span of time but all in vain .

8...That day by day torture inflicted by all the accused persons (No.1-7) as no child was born out of this wedlock. The Accused No.1 i.e. the husband of the complainant never visited any doctor to treat the complainant nor himself, despite of declare the petitioner as infertile lady. All the accused persons used to abuse petitioner as infertile lady (Banj Meye) during her stay in matrimonial house and also used threaten her to commit second marriage of the accused no.1.

9...That on 20/11/18 all the accused persons (No.1-7) by hatching a criminal conspiracy ousted the petitioner from her matrimonial house by beating her mercilessly. Since then the petitioner compelled to live upon the mercy of her parents in her parental house at village – Senabona, P.O. Hensla, P.S. Arsha, District- Purulia.

10)...That 27/06/2019 all the accused persons (No.1-7) along with some unknown person came to the parental house of the complainant at village – Senabona, P.O. Hensla, P.S. Arsha, District – Purulia, and asked her to sign in blank paper and when she refused to do so the accused persons beaten her mercilessly and forcefully make her sign in to a piece of blank paper, the father of the complainant was also assaulted by them. The Opposite Party threatens the complainant with dire consequences if she could not agree to sign for mutual divorce.

12...That the complainant came to know from her near relatives that the Accused No.1 performed second marriage on 24/07/2019 at "CHIRKA GOURINATH DHAM" temple, under Pirulia (M) P.S. with one Charubala Mahato D/O. Haribol Mahato of i.e. the accused No. village –Pratap pur, P.O. Salagram, P.S. Joypur, District – Purulia in presence of all the accused persons .

13... That your Complainant visited several times to lodge a written complaint over the above mentioned facts and circumstances before the Arsha P.S. but the Officer on duty did not pay any heed to her written complaint and on 8.08.19 your complainant sent the written complaint to Arsha P.S. through registered post.

14... That your complainant informs the matter stated above to the S.P. Purulia on 29.08.2019 but till date no action has been taken against the accused persons.

13. That having no other option left your complainant filing this Misc.Petition u/s 156 (3) of Cr.P.C. before this LD Court against the accused persons.

It is therefore prayed that your honour may graciously be pleased to admit this Misc. Petition filed u/s 156 (3) of Cr.P.C. and treating the same as a F.I.R. be pleased to send it to Arsha P.S. with a direction to proper Investigation and necessary steps against the accused person as alleged in the petition by the Complainant.
