I do hereby lodge complaint empowered by enabling the electricity act 2003 subsequently the amendment act 2007 to the effect that, Sri Haru Singh Mura S/O- lt Badi Singh Mura of village Tunturi, P.O- P.S- Bagmundi Dist- Purulia has committed theft of electricity U/S 135(1) (a) of electricity act 2003 subsequently amendment act 2007.

On 17-09-19 at about 04.30pm I Sri Swapan Kumar Das, AE & Station Manager, Bagmundih CCC along with 1. Sri Dipankari Bera Manager (FIA) Purulia R.M. Office, 2. Sri Sukhamoy Maji AE(U) Bagmundi CCC entered the premises of Sri Haru Singh Mura, S/O- lt Badi Singh Mura of village Tunturi, P.O- P.S- Bagmundi, Dist- Purulia and found Sri Haru Singh Mura was enjoying electricity unauthorizedly drawing power from the nearest L & MV line of WBSEDCL through PVC wire by means direct hooking to his house premises and connected load found 0.1 KVA. As Sri Haru Singh Mura S/O- lt Badi Singh Mura committed theft of electric power, So, I seized the following articles after preparing the seizure list in presence of 1. Sri Dipankari Bera Manager (FIA) Purulia R.M. Office 2. Sukhamoy Maji AE(U) Bagmundi CCC. The inspection team left the premises at 04.40 P.M Dt- 17-09-19
