



- 3. That after elapsing a considerable period the daughter of your complainant did not reach the Hospital. At this the family members of your complainant become worried and searched their level best at every possible places and came to know that one Sandip Beda, S/O Dhana Beda of village PradhanKanta, P.S. Beliapur, District Dhanbad (JH) kidnapped his minor daughter.
- 4. That at this thereafter your complainant approached before the house of the accused no 1 namely Sandip Beda where he inquired about her minor daughter at this the uncle (Jhatha Mosai) namely Kora Beda accd. No 2 become furious and abused and assaulted your complainant with fist and blows and threatened your complainant with dire consequences and compell to your complainant to leave the place.
- 5. That your complainant has every reason to belive that her minor daughter Jhunpuki Beda is being abused and exploited Sexually by the accd no 1 with the help of other accd. no 2 keeping a secrets place.

That thereafter your complainant went to the local P.S. at Balarampur and also informed the matter to the Superintendent of Police Purulia but till today not any action has yet been taken by the police of Balarampur P.S. against the accd. persons. - That the accd. person have committed the offence and they 8. are liable to be punished accordingly.
- 8. That your complainant is a poor person and he has not in position to pull or conduct of the complaint case for all such reasons the police case is desirable.
