

- 4. That the complainant was well behaved only three months. After three months the accused No.1 asked the complainant to bring Rs. 1,00,000/- (Rupees one lakh) only for the purpose of business which all the family members of the accused persons supported the same.
- 5. That the complainant informed the matter to her father who have no source of income, the father of the complainant expressed his inability of paying the money.
- 6. That as the further demand of Rs. 1,00,000/- (rupees one lakh) was not paid to the accused No.1 the accused No.1 along with family members started physically and mentally tortured upon the complainant and even denied proper food and cloth.
- 7. That the complainant living there bearing all sorts of torture with hope that a good days will come.
- That all the incident informed to the local Panchayet
