Sub: Complaint against Fagu Singh Sardar (55 yrs) S/O- Lt. Chayan Singh Sardar of Vill.- Malti, P.S.- Balarampur, Dist. Purulia to start a cog case U/S-46A(C)B.E. Act.

Respected Sir,

In producing here with one arrested accused person namely Fagu Singh Sardar (55 yrs) S/O- Lt. Chayan Singh Sardar of Vill.- Malti, P.S.- Balarampur, Dist. Purulia along with seized i) Approx 12 (twelve) Litres ID Liquor in a Black Jarican, ii) Approx 600 ML ID Liquor, in a Plastic Bottle separately taken sealed and label for Chemical Examination out of 12 litters, iii) 10 (ten) Pieces Plastic Glass (details of seized articles are mentioned in attached seizure list), I beg to submit that today at about 18:15 hrs. I received a credible source information that one Fagu Singh Sardar S/O- Lt. Chayan Singh Sardar of Vill.- Malti, P.S.- Balarampur, Dist. Purulia is selling ID liquor without any valid license from his own house at village Malti under Balarampur P.S., Dist.-Purulia. Accordingly, I inform to O/C Balarampur P.S. regarding this matter and as per order of O/C Balarampur P.S. I along with officer & force left for village Malti to work out the source information. Thereafter we reached at Village Malti at about 18:30 hrs as per source information and held raid in the house of Fagu Singh Sardar.

During search with the help of accompany with officer & force, we found that the said person is selling ID Liquor in his own house. On demand, he failed to produce any valid documents or valid License in respect of selling and keeping of said ID Liquor. Accordingly, I seized all the ID Liquor (details in seizure list) after preparing proper seizure list duly signed by the witnesses and labelled Approx 600 ML ID Liquor as a sample. Total i) Approx 12 (twelve) Litres ID Liquor in a Black Jarican, ii) Approx 600 ML ID Liquor, in a Plastic Bottle separately taken sealed and label for Chemical Examination out of 12 litters, iii) 10 (ten) Pieces Plastic Glass and arrested him after preparing proper arrest memo as he committed offence U/S 46A(C) B.E. Act 1909 after maintaining all the formalities as per NHRC guide line.

Under the above circumstances and fact, I therefore pray that a cog case may kindly be started U/S 46A(C)B.E. Act against the arrested accused person namely Fagu Singh Sardar (55 yrs) S/O- Lt. Chayan Singh Sardar of Vill.- Malti, P.S.- Balarampur, Dist. Purulia to start a cog case U/S 46A(C)B.E. Act and arrange for its investigation.
