I do hereby lodge complaint, empowered by enabling "The Electricity Act, 2003" subsequently electricity act-2007, to the effect that JHABU MURMU, S/O LT. ANIL MURMU of Vill- MURGABONI BASTI, P.S- Barabazar, Dist- Purulia, his family was enjoying electricity illegally hooking from nearest LT OH line with the help of two core flexible wire and he has committed theft of electricity U/S 135(1)/a of the electricity (Amendment act-2007).

On 11.09.2019, I Sri ANSHUMAN MITRA, A.E. & S.M., BARABAZAR CCC, WBSEDCL along with

- (1) MD QASIM ANSARI, O.E., BARABAZAR CCC, WBSEDCL
- (2) NADEEM ANJUM, O.E., BARABAZAR CCC, WBSEDCL

At About 05:40 P.M., entered into the premises of JHABU MURMU, S/O LT. ANIL MURMU of Vill- MURGABONI BASTI, P.S- Barabazar, Dist- Purulia and inspected his premises at Vill.- MURGABONI BASTI, P.S Barabazar, DIST- Purulia.

During inspection, it was found that JHABU MURMU, S/O LT. ANIL MURMU of Vill- MURGABONI BASTI, P.S- Barabazar, Dist.- Purulia, his family was enjoying electricity illegally hooking from nearest LT OH line with the help of two core flexible wire in his premises at MURGABONI BASTI having connected load 0.118 KVA.

From the above arrangement he was using the following arrangements:

01. 01 no electric Bulb (100 watts)
02. 2 core flexible wire (20 Mtr. App.) along with hooking device.

Out of which I seized the following articles:

01. 01 no electric Bulb (100 watts) with holder
02. 2 core flexible wire (20 Mtr. App.) along with hooking device.

Seizure list was prepared at site. After process of inspection and seizure list we left the premises at about 05:58 p.m.

The said person has committed an offence U/S 135(1)/a of electricity act 2003 subsequently electricity (Amendment) act-2007.

You are requested to take cognizance of this complaint and treat it as F.I.R and action may be taken as per rule.
