

3)___That due rash and negligent driving of the driver bearing registration NO WB 56 /C/ 8579 the said accident took place as a result the aforesaid vehicle bearing NO WB/ 56/ P /3827 has been fully damaged and the person who were sitting on the said vehicle namely Bamdev Roy & his friend Shrikanta Mahato sustained serious injured on their persons after accident with the helped of the local People the injured were brought to the Primary Health` center Hura District Purulia and after first-aid-treatment and seeing their serious condition Doctors of said Health center referred the to Higher Medical center for better treatment so the patients /injure persons were admitted at Deben Mahato Sadar Hospital Purulia after that shifted to the Rotary club & Hospital Purulia and after the medical & pathological investigation Doctor informed the complainant that due that accident broke the ankle bone of complainant said son Bamdeb Roy and thereafter steel plate is fitted in his left leg by the operation and he is now became a physically handicap person & undergoing treatment and not in position to perform any work That under the above circumstance Complainant was too much busy for his sons treatment & occurrence That thereafter complainant went to the Hura Police station dated 07-07-2019 and narrated the entered incident and submitted a written complain against the offending vehicle Driver bearing registration NO_WB 56 C 8579 That Police of Hura P,5 assured the complainant to take legal action against the offending vehicle driver bearing registration NO WB/156 = 8579 That furthermore the complainant went many times and met the Police but the Police did not listen That complainant further submit that he has come to know that Police has not registered any case against the offending vehicle driver and nor has visited the place of occurrence also started a false case against the victim vehicle driver cum owner Bamdev-Roy That Hura PS Police has gone in w collusion with the accused vehicle driver bearing registration NO WB .56 c 85 \pm 9 Police did not instituted any case against the offending vehicle Driver bearing registration no WB/ 56 @ 8579
